PA Judge Dismisses Family Fed's lawsuit Against Sanctuary

On March 30, 2022, Judge Jennifer P. Wilson dismissed the HSAUWC lawsuit (filed on July 30, 2018) that sought to prevent Sanctuary Church from using the Tongil symbol and the term "Cheon Il Guk" in any of its events, broadcasts or publications.


